(TVFI)

[Registered under the society registration act 1860 (Rule 21 of Act 1860)]

Adopted on 02.01,2018, In the Special General Body Meeting held at 20, Sun City Rd, Sun City, Anand Nagar, Pune, Maharashtra 411051,

Pune –Maharashtra, and as amended on 21.10.2019

THE NAME OF THESOCIETY

The name of the Society is " TENNISVOLLEYBALL FEDERATION OF INDIA" and in short

TVFI.

2. THE REGISTERED OFFICE

The Registered of the Federation will be situated at the place of General Secretary/ President of the Federation whenever elected.

3. **JURISDICTION**:

Thejurisdiction of the federation will extend to all states and union territories (U.T) of India having governing bodies of TENNISVOLLEY BALL (as described in 8,2), which accept and agree to abide by the provisions of this constitution and rules framed by TVFI, The jurisdiction will also extend to the Institutions and/or organizations of any nature including NGO's of all India Nature having either governing bodies for TENNISVOLLEY BALL and/or Sports like Services Sports Control Board, Railway Sports Promotion Control Boardetc,

4. THE OBJECTS FOR WHICH THE SOCIETY IS REGISTEREDARE:

- 4.1 The Tennisvolleyball Federation of India, being part of the International Tennisvolleyball
 - Federation(ITVF) and Asian Tennis volley ball federation (ATVF) under taketore spectprovisions of the International Tennis volley ball Federation and Asian Tennis volley ball Federation, the Olympic movement, the World Anti-Doping Code and to a bid by the decisions of the international Tennis volley ball Federation and Asian Tennis volley ball Federation,
- 4.2 The TVFI will maintain its affiliation to IVFI, ATVF, IOA.
- 4.3 AtNationalleveltoparticipateinactionstopromotepeace, promotewomenan dpromotethegame of Tennisvolleyball in it's all the forms like Tennisvolleyball, Indoor Tennisvolleyball and sitting Tennisvolleyball for

- handicapped or any variation evolved at a laterstage)
- 4.4 To help and assist Indian Olympic Association to develop, promote & protect the Olympic movement in India in accordance with the OlympicCharter.
- 4.5 To support and encourage the promotion of sports ethics particularly in Tennisvolleyball to fight against doping and to demonstrate a responsible concern to environmentalissues.
- 4.6 Topromoteandencouragethephysical, moral and cultural education to the yout hofthen ation for the development of character, good health and good citizenship.
- 4.7 To enforce all rules and regulations of the International Tennisvolleyball Federation, Asian Tennisvolleyball Federation and the Indian Olympic Association (IOA) and not to indulge in or associatewithanyactivitywhichisincontradictionwithrulesoftheInternational Tennisvolleyball Federation, Asian Tennisvolleyball Federation, the Indian Olympic Association and Olympic Charter. TVFI will frame its own rules for the game, match, championships and tournaments in line with the rules of ITVF, TVFI and IOA to suit Nationalrequirements,
- 4.8 Tobetheofficialorganizationhavingcompleteandsolechargeofalltheformsof Tennisvolleyball (as described in 8.2) in thecountry.
- 4.9 To educate the public of the country as to the value ofsports.
- 4.10 To maintain the highest ideals of sport and to promote interest therein, particularly in connection with the Games under the patronage of the IOC, OCA, SAOC, IDA, ITVF, TVFI as well as any other affiliate body of any of the 6 bodies listed in thisparagraph.
- 4.11 To have full and complete jurisdiction over all .matters pertaining to the participation of Indian Tennisvolleyball Teams in Games under the patronage of IOC, OCA, or their affiliatebodies,
- 4.12 TocertifytheeligibilityofplayersofTennisvolleyballofIndiaforsuchinternation alCompetitions which require suchcertification
- 4.13 To stimulate the interest of the people of the country in the promotion of sports particularly Tennisvolleyball.
- 4.14 ToactasthechannelofcommunicationbetweenStateandU.TTennisvolleyball Associations, and the Government of India for financial or other assistance to theAssociations.
- 4.15 To admit the membership of State Tennisvolleyball Associations, Tennisvolleyball Associations of Union Territories and All India Organizations which will be required to submit their constitution, Annual Reports, Results of the State Championships conducted and Audited statement of accounts to the TVFI.
- 4.16 To take disciplinary action against any Member unit for misbehavior or any other undesirable activity bringing discredit to the Country, TVFI and

- 4.19 To resist in the realm of Tennisvolleyball all pressures of any kind, whether of a political, legal, racial, religious or economic nature.
- 4.20 TotakestepsforthecreationofNationalTennisvolleyballAcademies,Tennisvol leyballMuseums, other cultural and promotional institutes related toTennisvolleyball.
- 4.21 Toresistandopposeanyformofdiscriminationongroundsofrace, religion, legal , politics, gender or otherwise and to resist violence in Tennis volleyball.
- 4.22 To lay down guidelines to enforce the World Anti-Doping Code of the international Olympic Committee and international Tennisvolleyball Federation to fight against the use of substanceand procedures prohibited by the International Olympic Committee and / or the International TennisvolleyballFederationandtoadoptandimplementWorldAntiDopingAg encyCodethereby

ensuring that the TVFI's Anti Doping policies and rules, membership and/or funding requirement

andresults, management procedures conform with the World Anti Doping Code and respectable the roles and responsibilities for National Sports Federations that are listed within the World Anti Doping Code.

- 8.4 The General Assembly means and includes the Representatives deputed by the Member Units in accordance with the Rules hereinaftercontained,
- 8.5 Constitution means The Constitution of the Tennisvolleyball Federation ofIndia
- 8.6 "The Executive Committee' means the Executive Council of the Tennisvolleyball Federation of India constituted / elected under the Rules and Regulations hereinafter contained to whom the Management of the affairs of the Federation isentrusted.
- 8.7 Club-institution-TheOrganization/groupofindividualsdulyaffiliatedtotheDistrictAssociation affiliated to the StateAssociation.
- 8.8 Association means affiliated Units of the TVFI e.g., State or Union Territory Tennisvolleyball Association having control over all forms of Tennisvolleyball as described in article8.2.

9. **ASSOCIATION FINANCIAL YEAR:**

10. MEMBERSHIP:

- 11.2 The Membership Fee will be paid on or before 31st August of every year. - 11.3 Even after serving of registered notice by the TVFI Treasurer, if a Member Unit does not pay the renewal fee along with the full applicable penalty fee on or before the last day of March of the same financial year, the TVFI Executive Council will recommend to the General Assembly the disaffiliation of themember of the TVFI. The decision of the TVFI General Assembly ywill be final in this respect

12. ANNUAL GENERALMEETINGS:

- 12.1 The Annual General Meeting (Also Known as Annual Meeting of the General Assembly) will be held every year at a Place, Date and Time to be decided upon by the President/ General Secretary.
- 12.2 The normal Agenda of the Annual/Special General meetings, amongst other things, willbe:
- a. Confirmation of the Minutes of the last Annual Generalmeeting
- b. Consideration and adoption of the Annual Report of the Secretary General
- c. Consideration and passing of audited Statement of Accounts for the previous financial year, and budget for the nextyear
- d. Appointment of Auditors and fixing their remuneration.
- e. General Elections, ifdue
- f. Consideration of the Annual Sports Calendar of the Federation
- g. Any other matter with the permission of thechair.

13. SPECIAL GENERALMEETING:

13.1 Special General meeting may be summoned at any time by the President /General Secretary of TVFI at his discretion

Will be convened on a written requisition signed by Presidents and Secretaries of more than 50%

13.2 To pass a resolution of no confidence, it will be a mandatory requirement that such resolution against the President, Secretary General, Treasurer and other Executive Council Membersbe

passed only by 2/3 members present and voting. A resolution of no-confidence not supported by

2/3majoritywillbedeemedtohavefallenthroughandthemotionwillbetreatedasnullan dvoid. The quorum for such meeting will be 3/4 of the total strength of the representatives of the TVFI entitled tovote,

15.2 Eligibility & Tenure for President and General Secretary –

- **a.** Tenure for the post of president shall be maximum of three terms of 4 years .i.e Maximum of 12 years with or with out break .
- b. Tenure for the post of General Secretary shall be two consecutive terms of 4 years i.e maximum of 8 years and after a colling of period of 4 year my be eligible for seeking fresh elections for either of the post.
- **c.** President, General Secretary and treasurer shall cease to hold the post on attending the age of 70 years .
- 15.3 Eligibility Criteria for the candidates for election for all the posts as described in 15.1(1 to 6) are as follows:
- 15.3.1. He / She should be a citizen ofIndia

- 15.3.2. He / She should not be less than 25 years of age on the date of Nomination.
- 15.3.3. He / She should not be an office bearer of any other National Sports Federation except Indian OlympicAssociation.
- 15.3.4. He / She should not have been convicted by any court for any offence involving moralturpitude
- 15.3.5 He / She has not been declaredinsolvent
- 15.3.6 He / She should not beinsane.
- 15.3.7. Any Government employee will be Not be eligible for contesting the election in the federation subject to approval/prior permission under respective service rules, of respective government to such employee, to contest theelection.
- 15.3.8. AllsuchGovernmentemployeeswillnot beeligibletocontesttheelectiononlyfortwo termor5years whicheverisless in this regard any subsequent instructions issued by the department of personal and training 'ministry of youth affairs and sports 'government of India will be automatically applicable ,providedsuchgovernmentemployeewillholdthepostonlyuptoheremainsin service of such employer which granted thepermission.
- 15.3.9. If a member does not pay his membership fee prior to 31st March of every year, his membership will stand ascancelled.
- 15.3.10. If a member does attend Annual General Meeting continuously for three years, then also his membership will stand ascancelled.

15.4. Authorization to attend the General BodyMeeting

- 15.4.1 Affiliated Members will forward the names of the representatives who should be the members of the Affiliate Member unit, entitled to attend General the Annual Meeting 15 days prior to the holdingtheAnnualGeneralMeetinginwhichtheelectionsofTVFlarescheduled, tothesecretary of TVFI. Preferably the President and Secretary of the affiliated Member unit should attend the meeting in person, but if they are unable to attend the meeting they should nominate a person by joint signatures authorizing him/her to attend the meeting. In case of a dispute between President and Secretary the Nomination) done by the President willprevail.
- 15.42 Affiliated Members will forward the names of the representatives who should be the members of the Affiliated Member unit, entitled to attend the Annual General Meeting prior to the holdingthe Annual General Meeting, to the secretary of TVFI. Preferably the President and Secretary of the affiliated Member unit should attend the meeting in person, but if they are unable to attend the meeting they should nominate a person by

joint signatures authorizing him / her to attend the meeting. In case of a dispute between President and Secretary the Nomination(s) done by the President willprevail.

15.4.3. Any vacancy which occurs in Executive Council will be filled by election at the the

earliest .

- 15.5 The Executive Council will be elected by the TVFI General Assembly.
- 15.6 3 (Three) Associate Vice Presidents and 3 (Three) Associate Joint Secretaries will be nominated by the General Assembly who will be the part of Executive Council, but will not have the voting rights.
- 15.7 Life chairman At the General Assembly of TVFI the house may nominate a person who has rendered unique and distinguished services for the cause of TVFI in the country as Life Chairman of TVFI.
- 15.8 Holding of Office No office-bearer of TVFI will be eligible to be office bearer simultaneously in any other National Sports Federation, excluding Indian Olympic Association.

16. ELECTION PROCEDURE:

The procedure for election of the members of the Executive Council will be as follows:

- 16.1 The Executive Council in charge will declare the election as per the provisions of National Sports Development Code 2011 as amended time to time, and the elections will be conducted as per the provisions of National Sports Development Code 2011 as amended time to time or as per the guidelines of GOI.
- 162 At the Annual General Meetings and Special General Meetings of the TVFI the following Members state Tennisvolleyball Associations and U.T tennis volleyball Associations will be represented by two

17. DUTIES OF OFFICEBEARERS

- 17.1 Life Chairman: Life chairman will be the friend, philosopher, and guide to the federation, the chairman will have no right to cast his vote at annual general meeting, but will have the right to represent TVFI at all INTERNATIONAL FORUM subject to the approval of the general assembly
 - 17.2 PRESIDENT The President will be the Executive Head of the If a member does not pay his membership fee prior to 31st March; his membership will stand as cancelled. Federation of India and will preside over all meetings of the General Assembly and Executive Council. He will guide the If a member does not pay his membership fee prior to 31st March; his membership will stand as cancelled. Federation of India in all its activities. He will exercise superintendence over office- bearers and members of the Executive Council and other Commissions in the discharge of their duties. He will have overall powers of supervision over the working of the

Association and its efficient administration. In particular, the President will have the following powers/responsibilities:-

The President, TVFI, is authorized 2500000/to sanction expenditure up to Rs. for any oneitem. Expenditures anctioned in excess of Rs. 2500000/hastoberegularizedbytheExecutive CouncilandbeyondRs.10000000/the expenditure has to be regulated by the General Assembly.
- iii. To call a meeting of the Executive Council and the General Assembly through the General Secretary as and when necessary and will perform such other duties attached to theoffice.
- iv. To cast his vote in case of atie.

v To take any disciplinary action (other than the removal from office) in case of exigencies as and when arise. The President will in the best interest of the Federation and game will take any disciplinary action (other than the removal from office) as he deems fit against any of the office bearers of the federation, affiliated units, its office bearers and individuals connected to the federation and/or affiliated members in any manner or in any capacity who has acted against the interest of the federation and the game and caused damage / injuries to the image / functioning of the federation and having evidence of such misdeeds m initiating such disciplinary action by the

President. The action taken by the President will be communicated to the Secretary Gener alofthe federation, who in turn will communicate the same to all the office bearers of the federation, affiliated units and will place it before the General body meeting of the federation, which takes place immediately after this.

- vi. To be the Chairman of the selection committee to select the National Team(s) of Tennis volley ball to represent the country.
- vii. To appoint the selection Committee to select the Indian TennisvolleyballTeam(s).
- viii. To suspend any member association its office bearers, member of a member association or their office bearer, player, referee/umpire (Technical Officials), Coach and any other support staff like physiotherapist etc. during enquiry and appoint enquiry officer / committee to inquire such misconduct, misbehavior, misappropriation or any untoward act of such person /association.
- ix. If president is unable to held his responsibilities that time, the life Chairman will be perform all the responsibilities of President of TVFI

17.3 VICEPRESIDENT(s)-

IntheabsenceofthePresidentandChairmanOneoftheVicePresidents as directed by the president / chairman as the case may be, will preside over the meetings and discharge duties and function as directed by thePresident.

17.4 GENERAL SECRETARY - The General Secretary will be in charge of the day-to-day administration of the Federation and will transact all official business in accordance with the direction of the President, TVFI General Assembly and Executive Council He will be responsible for calling meetings of the TVFI Annual General/Special General Assembly/Executive Council, as per rules and to implement their decisions. He will be responsible for carrying on all correspondence in the name of the Federation save as otherwise directed by the President. Hewill keep and maintain the minutes of all meetings of the TVFI General Assembly and Executive Councilofthefederation, the register of Members and all such records as may benecessaryforthe

smoothandefficientworkingoftheFederation,Hewillalsoberesponsibleforthemainte nanceof the properties (Movable and Immovable) of the Federation. He will prepare and submit at the Annual General meetings of the Association his Annual Report. He will convene meetings of the Federation under the directive of the President. The financial powers of the Secretary General are restricted to sanctioning of Rs. 50000/- for any oneitem.

17.5. **TREASURER** - He will be responsible for the management of the finances of the Federation and ensure that the accounts of the Federation have been maintained properly and audited regularly. He will receive all moneys of the Federation and will pay all bills certified by the President, Secretary General, unless the amount of a bill exceeds the limits of the sanctioning authority or the budgeted amount in which case, the amount must have sanction of the competent authority (before it is paid). He will prepare and submit an Annual income and Expenditure Account, togetherwithadulyAuditedBalance-Sheet.HewillalsomaintainaninventoryoftheFederation's propertyandsubmitthesamealongwiththeaccounts.HewillprepareandsubmittotheSe cretary

Generalthelistofallmemberunitswhohavedefaultedonthepaymentoftheiraffiliationr enewal fee and penalty dues, within the stipulated period oftime.

17.6 **JOINT SECRET**ARY - He shall do all such things and exercise all such powers as will be delegated to him by the Executive Committee or the GeneralSecretary,

17.7 **To represent TVFI**: When CEO is being nominated to represent TVFI at all or any International forum(s) like TVFI, ITVF, IOA, OCA, IOC etc, either President or General Secretary of TVFI as per the decision of its Executive Committee will also represent TVFI at all or any International Forum(s) like TVFI, ITVF, IOA, OCA, IOCetc.

18 BANKACCOUNT:

An account or accounts will be maintained in such Scheduled or Nationalized Bank or Banks, as may be approved by the Executive Council in the name of the Federation and will be jointly operated upon by the Treasurer and the President / the Secretary General.

19 AUDITORS:

The Auditors will be appointed by the General Assembly and their remuneration will be negotiated and fixed by the President or General Secretary as the case maybe.

20 GENERAL ASSEMBLY, POWERS, FUNCTIONS AND DUTIES:

- **20.2** To formulate and enforce the policy of the Federation
- **20.3** To carry into effect the objects of the Federation
- **20.4** To hold election of office-bearers and the Executive Council every four years, in accordance with the provisions of this Constitution
- **20.5** To admit to membership of any organization eligible under tins Constitution or to delegate these powerstoeitherPresidentorGeneralSecretaryofthefederationalIsuchdeci sionstakenbyvirtue of delegated powers will be ratified by the General Assembly in its nextmeeting.
- **20.6** To hold and control the funds and other properties of the Federation
- **20.7** To consider the Annual Report of the Secretary General, audited statement of accounts for the previous financial year, Budget Estimates of the federation, and to appointAuditors,
- **20.8** To appoint committees or sub-committees, as and whennecessary
- **20.9** To enforce all rules and regulations of the International Tennisvolleyball Federation
- 20.10 To act as the channel of communication between the Member units and the Government of India for financial or other assistance to them.
- 20.11 ToadmittoMembershipofStateTennisvolleyballAssociations,Tennisvo lleyballAssociationsof Union Territories and Organizations of All India Level or to delegate these powers to either President or General Secretary of the federation. Ail such decisions taken by virtue of delegated powers will be ratified by the General Assembly in its

- nextmeeting.
- **20.12** To consider and take decision on disciplinary inquiry (ies), report(s) and impose penalties as provided in article 24.5.
- **20.13** To have powers to frame bye-laws and rules which are consistent with the Constitution
- **20.14** To delegate any or all power(s) to the President and / or General Secretary to take the decision in the best interest of the federation and all such decisions will be ratified by the Genera! Assembly in its nextmeeting.
- **20.15** To appoint an ad-hoc committee to manage the affairs of Tennisvolleyball in any member unit, from and among the local representatives, other than the persons who failed to maintain the democratic process in the association for found guilty of any othermisconduct.

21 POWERS, FUNCTIONS AND DUTIES OF THE EXECUTIVECOUNCIL:

- **21.2** The Executive Council of the Federation will comprise of The President and other officebearers.
- 21.3 To conduct the business of the Federation during the interval between meetings of the General Assembly and duly report all the decisions and the actions to the General Assembly for its information.
- 21.4 To be responsible for the proper supervision of the Indian Tennisvolleyball teams for the Asian Games, Asian Indoor Games, Asian Beach Games, South Asian Games, South Asian Beach Games, WorldCuporanyotherInternationalSportsEventsorganizedbyIO Coritsaffiliatebodies during the period of the Games and their trip to and from the Games. (Olympic Games and Commonwealth Games will be considered included here as & when Tennisvolleyball is included in thesame]
- **21.5** To initiate and recommend to the General Assembly schemes for the promotion and development of Tennisvolleyball in the country,
- **21.6** To consider the Annual Report of the Secretary General and submit it to the General Assembly with their recommendations
- 21.7 To delegate any or all power(s) to the President and / or Secretary to take the decision in the best interest of the federation and all such decisions will be ratified by the General Assembly in its next meeting.

22 RESPONSIBILITIES OF AFFILIATED MEMBER UNITS /ORGANIZATIONS:

22.2TheMemberunits

- should be organized through Inter BlockandIntra-DistrictcompetitionsineachDistrict,leadingtothecompetitionattheStatel evel.
- **22.3**Each member organization shall send its team for participation in National Championship. Itshall also ensure that its athletes / Players actually take part in the Championship.
- 22.4Any member unit failing to send its team or whose competitors do not turn up for participation without reasonable excuse for two consecutive years shall be liable for disciplinary action by the General Secretary who may suspend the team from participation permanently after giving an opportunity to the said unit to show cause against the proposedaction.
- **22.5**In addition, the Executive Committee is also empowered to suspend foe a period of two years the team whose entries after being received (ail to participate without any reasonable excuse.
- 22.6It will be binding on all the Member Units affiliated to the Tennisvolleyball Federation of Indiato forward their Annual report, Audited Statement of Accounts and Constitution along with its amendments (if any) every year latest by 15th April. The affiliated units will also conduct their elections as and when due. The non-compliance of these requirements may result in disaffiliation of the defaulting Units by the TVFI General Assembly on the recommendations of the Executive Council.
- **22.7**No member organization shall send any active competitors to represent in the meetings of the Executive Committee or GeneralCouncil.
- **22.8**Each member organization shall send to the Federation a list of all its affiliated units /Clubs.
- **22.9**Any member um? or any unit afflicted to the member unit intending to hold All Indiacompetition shall obtain written permission from the Honorary General Secretary or President in accordance with the rulesframed.
- **22.10** Disciplinaryactionwhenevertakenbyanymemberorganizationagainstit sownmembersshallbe reported to Honorary General Secretary within a month, which will keep a record of it andinform other member organizations aboutit.
- **22.11** On receiving special request the Executive Committee can review such actions taken by the member organizations and send its recommendations toit.
- **22.12** All correspondence, to the Indian Olympic Association, International Bodies and Government of India shall be routed exclusively through Tennisvolleyball Federation of India. Any default

- inthis respect shall render the unit liable for disciplinary action.
- **22.13** Every affiliated State Unit shall maintain properly and regularly audited accounts of the Association and the minutes of the business meeting, and hold meeting of the General Body and Executive Committee regularly in accordance with its Constitution.
- **22.14** Each State Association/affiliated unit of the Federation shall appoint only qualified coaches to coach the State Teams. They shall appoint qualified officials to officiate the matches at the State meets.
- 22.15 No member unit will be allowed to grant voting rights to neindividuals

23 AMENDMENT OF CONSTITUTION—

The constitution of the **Tennisvolleyball Federation of India** can be altered or added or

substituted by vote of two third members present and voting at a General Council meeting specially convened for the purpose.

24 GENERAL DISCIPLINARY REGULATIONS:

- 24.1. Violation of the existing rules cannot be excused on grounds of ignorance of the saidrules
- 24.2. The President, TVFI will have the power to call for explanation from its member units regarding the issues where a sports-person has been found guilty of violating World Anti Doping Code, National Anti Doping Code and Anti Doping Code of TVFI but no action has been taken by the concerned member unit. The recommendations of the TVFI President will be placed before the General body for appropriate disciplinary action as per the Anti Doping Code of TVFI.
- 24.3 Disciplinary Sanctions The TVFI member Units its office bearers, member of a member associationortheirofficebearer, player, referee/umpire(TechnicalOfficials), C oachandanyother support staff like physiotherapist etc. are liable to the following penalty (ies):-
- 24.3.1 Caution:
- 24.3.2 Warning
- 24.3.3. Suspension
- **24.3.4.** Expulsion from TVFI or life ban from ail formats of the game of **Tennisvolleyball**.
- 24.4 Appeal Any decision taken by the TVFI is subject to appeal before the Arbitration Commission of TVFI within 30 days after the receipt of the decision
- 24.5 AllMemberUnitsofTVFIwillcommitthemselvestorefertheirunresolveddisput esforsettlement through the process of Arbitration with the Arbitration Commission which would be highest independent authority for the

resolution of disputes.

25 SETTLEMENT OF DISPUTES/CONFLICTS IN THE MEMBERSUNITS:

All State Tennisvolleyball Associations and members units affiliated to TVFI will include in their Constitution a provision that the Associations would have all unresolved disputes settled by the Arbitration Commission of TVFI.

26 BREACH OFETHICS:

All matters in relation to breach of Ethics will be referred to the Ethics Commission of the TVFI

in relation to every one connected with Tennis volley ball for decision as per the provisions of TVFI.

27 UN-SPORTSMAN LIKE BEHAVIOR AND ACT OF VIOLENCE:

During the Olympics, Commonwealth Games, Asian Games, SAF Games and National level competitions, or any other International competitions, any unsportsman like behavior on the part

ofasportsperson, official or coach, which includes insulting, making undesirable gestures, abusing the decision of the Judges/Referees and provoking the opponent*, or spectators, etc. in a word, committing any act not in keeping with the propriety of sports, will be punished as follows:

- i Disqualification for the duration of the activity of that item of sports; ii Disqualification for the entire duration of the competition,
- iii Prohibition from participation in future competitions for a fixed period oftime.

28 RESIDUAL POWERS:

In the event of disagreement concerning the above Disciplinary Rules, the interpretation of these

regulations will fall within the competence of the TVFIGeneral Assembly, which will be the efinal authority as and when referred by the Executive Council.

29. DISAFFILIATION/DE-RECOGNITION OF MEMBERUNITS:

- 29.1 The TVFI General Assembly, either directly or through the TVFI Executive Council, based on its discretion, is entitled to consider disaffiliation / derecognition / of the Member Unit of TVFI on one or more of the under mentioned grounds, after ensuring that a Show Cause Notice has been served and an explanation has been obtained and considered from the organization recommended for disaffiliation/de-recognition.
- 29.1.1 Non-observance of directives issued by the Tennisvolleyball federation of India from time totime

- 29.1.2 Not holding elections after the completion of the normal tenure for which the office bearers are elected
- 29.1.3. Not submitting annual audited statement of accounts, annual report, list of current office-bearers and list of affiliated units within Use stipulated time period,

30. THE AFFILIATED MEMBER UNITS WILL ABIDE BY THE CONSTITUTION OFTVFI

31. GRIEVANCE REDRESSAL OFATHLETES

Any active athlete having any grievance can write his grievance(es) to President or General Secretary along with documents if any, which will be attended by the President or General

Secretaryasperthecasemaybewithin30daysfromthedateofreceiptofthegrievance.Pre sident or General Secretary may constitute a Grievance Redressal Committee m order to address the grievance(s)

32. MISCELLANEOUS:

- 32.1 A member organization shall be represented only by its President, Secretary or representative) of theassociationandhis/theirletterofauthoritydulysignedbyPresidentandSecret ary(both)ofme association/ institution their representation letter must be submitted to the Honorary General Secretary prior to the commencement of themeeting,
- 32.2 OnlyoneSportsAssociationispermittedinoneState/U.T.Itimplies,therefore,th atinthefieldof Tennisvolleyball, it will be One State, OneUnit.
- 32.3 The Federation may sue or be sued in the name of the SecretaryGeneral,
- 32.4.In all matters relating to the interpretation and application of the Constitution, as well as in matters

notspecificallyprovidedforherein,thedecisionoftheGeneralAssemblywillbefinalandb inding on allconcerned

- The General Assembly upon recommendation being made by the Executive Council may, at its discretion, will frame by laws not inconsistent with or contrary to this Constitution, for the proper and efficient administration of the TVFI and its Executive Council.
- 32.6 The TVFI will be guided by the Statutes, Rules, Regulations by elaws, directions and instructions issued from time to time by the International TennisvolleyballFederation.
- 32.7 In case of interpretation difficulties of the Articles mentioned in this Constitution or m the eventuality of a conflict with the Rules of the International Tennis volley ball Federation't he Rules contained in the latter (International

- Tennisvolleyball Federation) willprevail,
- 32.8 The crest (Monogram) of the Tennisvolleyball Federation of action poses of Tennisvolleyball service in Wheatbrains.
- 329 The colours of the Flag shall be determinedly the ExecutiveCommittee.

33. WINDING UP:
